Meeting Minutes

Wednesday August 9th, 2023

6PM @ Black Hill Ranger Station

Gabrielle brought the meeting to order at 6:10 PM.

The July meeting minutes were reviewed and approved by the board via email on 7/17/23.

Treasurer's report

- John gave the treasurers report.
- One of the board's CD accounts was closed, and the funds were placed into the board's checking account.
- Discussion regarding the board transferring a CD account to another bank to secure a higher interest rate on the account. John will follow up with Cecil Bank to explore the feasibility of this transfer.

Maryland Big Tree Program Update:

- John gave the county report, and his report is provided below:

MBTP Report – July 2023

For Cecil – I asked some people in the Calvert area who is now responsible for the Calvert Oak and was given the name of the current contact person. This outreach is in response to a request to harvest acorns from the tree this year. I visited the tree; it has a heavy mast crop.

State – 14 trees were measured in July; 10 new trees and 4 re-measurements. Eight of the trees were in Montgomery County, four in Baltimore City and two in Frederick .

The Montgomery County team of Joli McCathran, Joe Howard and Vince Fillah measured/re-measured 8 trees in Montgomery. 4 are re-measurements and 4 are new trees. The smoothleaf elm and goldenraintree remain as State Champions. A new devil's walkingstick is the State-co-champion.

Fred Chalfant and Amanda Cunningham measured four newly nominated trees in Baltimore City. The white oak and Kwansan cherry are new city champions. The owner of the yellow poplar had a photo of his tree from 1929.

Bruce Phillips measured two new trees in Frederick County. The white oak belongs to an historic church, St. Josephs on Carrollton Manor Catholic Church—dating back to the Carrollton family whose member Charles Carrollton signed the Declaration of Independence. Unfortunately we have no record of the big white oak in church records.

Sadly the Bicentennial Linden white oak in Montgomery was taken down July 18th. It had died last year and it took a year for all necessary permits to be issued. A local artisan will carve a sculpture from the usable parts of the trunk. Both Joli and I were interviewed by a reporter from the Washington Post—article and video online. There are 8 remaining living Bicentennial trees that are publicly accessible—including the Calvert Oak in Cecil.
