Call to Order

Maryland Big Tree Program

John Provided the Big Tree Program Report:

December Big Tree Report

I understand the Maryland 250 calendar from the Maryland Forest Service has been printed.

CECIL – The Cecil Board measured 1 new tree—a yellow-poplar at 332 points—in the Perryville area. It has private ownership.

STATE – The Big Tree Centennial Contest – I received 3 nominations. All are multi-trunk yellow-poplars. As of 1/7, one tree has been measured and qualified. It has a circumference of 17' 1". It is located in Elk Neck State Forest near the fire tower.

51 trees were either measured or re-measured in December, as follows:

Anne Arundel – 4 new

Baltimore – 2 new, 1 remeasure

Carroll – 5 new

Cecil – 1 new

Frederick – 3 remeasure (State champion, GOAT Tree black locust)

Garrett – 1 remeasure

Howard – 1 new

Montgomery – 4 new

Prince George's – 3 new, 2 remeasure

Queen Anne's – 13 new (new State champion sassafras and new GOAT Tree)

Wicomico – 14 new (new State champion sand hickory)

Sassafras – 297 points – NEW GOAT TREE Sand hickory – 217 points
