### Call to Order

#### **Treasurer's report**

#### **Maryland Big Tree Program**

John Provided the Big Tree Program Report:

# **June Big Tree Report**

**CECIL** – I have mailed permission forms to two private big tree owners at the end of June as per policy. These owners did not respond to the January mailing. If

there is still no response, I will recommend that their trees be moved to the "Inactive" file.

**STATE** – **The Big Tree Centennial Contest** began on May 24<sup>th</sup>. To date there have been 3 enquiries but no qualifying nominations. **14** new nominations have been made for trees outside the contest area in June. Two of them in Frederick were measured and did not qualify.

I was interviewed on June 12<sup>th</sup> by Anna Rubenstein from the **Baltimore Banner**. The article appeared on June 30. The interview took place at Donaldson Brown Conference Center.

I was part of a meeting on June 24<sup>th</sup> regarding a possible Big Tree Centennial event in Western Region. The event was originally planned for the Kitzmiller Botanical Garden in Garrett County, but Melissa Nash was unable to confirm reservations with the Kitzmiller officials. I suggested the event be held in City Park in Hagerstown. There seemed to be general agreement with the idea, but I have heard nothing since then.

At the same meeting I suggested a calendar be developed as part of the 250 Commission's projects for the upcoming Semiquincentennial. A committee was to be formed. Nothing has happened since.

7 trees were measured/remeasured in June that qualified. Six were in Montgomery County, measured by McCathran, Howard, Fillah, Bergmann. They were red buckeye, pitch pine, pignut hickory, dawn redwood, pin oak, baldcypress. One was in Calvert County, measured by Balinski, Lee. It was a Port orford cedar.
